- Bids shall be opened in the presence of Bidders' representatives, who choose to attend at 2:00 PM on 2075/09/17 in Nagarain Municipality. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security amounting as stated above deposited at (**dharauti account No.0260010124952**) **on behalf of** Nagarain Municipality ,Nagarain ,Dhanusha at Mega Bank Nepal limited ,Nagarain ,Dhanusha or bid bond authorized from a recognized commercial bank of Nepal, which shall be **valid for minimum 30 days** beyond the bid validity period.
- If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
